By-Laws on Membership

1. Membership of the Society shall consist of:
 - (a) Ordinary Members who shall be members or regular worshippers whose names appear on a Methodist church roll; and
 - (b) Associate Members who shall be non-Methodist who subscribe to the objectives of the society and enjoy only rights and benefits as the board may from time to time allow.
2. Individuals applying for membership shall:
 - (a) have attained the age of 16 years;
 - (b) be citizens of/or residents in Singapore
 - (c) be in the opinion of the Board of good character
 - (d) not be legally or mentally disabled
 - (e) not be undischarged bankrupt; and
 - (f) not have a conviction standing against him for an offence punishable with imprisonment.
3. Application for membership shall be submitted on a form prescribed by the Board and shall be accompanied by payment for such number of shares that the applicant wishes to take up subject to By-laws 7.3 and the entrance fee provided that such payment shall be refunded where an application for membership has been rejected. Every application for membership shall be proposed by one member and seconded by another member.
4. The Board shall have power to approve or reject any application without assigning any reason thereof provided that an applicant so rejected may appeal in writing to a general meeting of the society.
5. Every member may in writing nominate one person in the presence of at least two witnesses, to whom his share, interest and all other sums due to him shall be paid on his death.
